### TERMS

The above parties agree to cooperate in the students and professors mobility activities shown below under the principles and conditions set out in The Erasmus Guidelines for Applicants and to include the referred exchanges in their respective Institutional Contracts. This agreement will be valid, except when the programs are of shorter duration, until the the Lifelong Learning Programme - Erasmus Agreement is finished.

Nevertheless, each institution may terminate the agreement simply by written notice to the other part. The termination of such agreement in no case may affect mobility activities already included in the Institutional Contracts, at the time of the communication.

This agreement will be valid only for the activities involved in it that are approved by the European Commission in the frame of the LLP-Erasmus program. Concerning students exchange, both parties commit themselves to receive under the LLP-Erasmus status the students nominated by the Partner University according to the agreed terms of this document.

However, the minimum number of Erasmus students and professors sent by each University will be subject to the existence of applicants and the budget of each Institution.
