- 2. The receiving institution will send its decision within 5 weeks.
- A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.
- 4. Termination of the agreement

This agreement is valid from the date of the last signature and shall remain in force **until May** 31, 2021.

This agreement may be amended or modified by a written agreement signed by the legal representatives of both Universities. It may be renewed on the same terms, or on terms as agreed by the two institutions.

In the event of unilateral termination, a written notice of at least one academic year is needed and started activities have to be finished in line with eventually signed documents. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

If the European Commission decides not to support the cooperation between our two institutions as agreed in this Inter-institutional Agreement, partner universities will then agree in writing about the realization of the cooperation agreed in this Inter-institutional Agreement.
